

### BYLAWS COMMENTS FROM MEMBERS:

- 1) The revised purpose of the bylaw change contains no reference to assisting the member in any manner and is now an advocacy organization for an undefined change of the built environment.
  - a) **Taken under advisement.**
- 2) Overall it makes no difference to me about writing things gender neutral. As for adoption of signs, and policy I would like to stay with "Internationally" approved signs and policy so that international travelers are not confused by the many different signs we have or the policies.

- 3) Article III: Voting. Either the last paragraph should be item c or it should be moved up to be under item a. As it is now under item b it does not apply since associate members may not vote.

- 4) Article IV: Treasurer. Second to last line is missing the r in treasurer.
  - a) **Edited.**
- 5) Article IV: Officer terms. Not sure why they changed, but recommend that all terms be two years. Also shouldn't be extended until a successor is named. The intent when we changed this originally was to limit voting to every two years.
  - a) **The previous bylaws had one year terms for all offices. We updated all terms to two years minus the VP.**
- 6) Article V: Election. Recommend voting every two years, not to stagger voting for some. We previously discussed that the past president will always carry over and most times others from the board typically carry over as well. As such, the need to stagger isn't really necessary. Also discussed having previous board member carry over for one board meeting to transition to new board member.
  - a) **Taken under advisement.**
- 7) Article VII: Amendments. Shouldn't they be approved by members, not by board?
  - a) **Article VII: Amendments were not changed. Taken under advisement.**
- 8) Article VII: Meetings. If a presenter is a CASI member, shouldn't their fees be waived as well for both seminar (obviously) but for the meeting as well? Shouldn't this apply to the meeting organizer as well?
  - a) **Presenters fees are already waived by policy.**
- 9) Article VIII. Indemnification. Recommend including committee members and chairs as well. We discussed this at one time.
  - a) **They are covered under CASI DNO policy. Committee members and chairs added to Article VIII.**
- 10) Article VIII: Being picky....in sentences will be officer, director, or employee, others the order is changed to director, officer, or employee. Recommend that it consistently be officer, director, or employee.
  - a) **Edited.**
- 11) Article IX: Logo. I guess it should be made clear that an associate member is not allowed to use the logo either.
  - a) **Edited.**
- 12) Article X: Publication and Article VII amendments should be better coordinated. It's a bit unclear what is required between the two.
  - a) **Taken under advisement.**
- 13) I prefer that document is justified on the right of the page too, it just looks better.
